

COVID-19 – Re-opening Documentation

– Facility Plan & Protocols

- **Everyone will be screened upon entry, Check-in**
- **On-line Self-Assessment Form will have to be submitted the day of a booking, this includes participants & coaching staff**
- **Temperature will be taken with a non-touch thermometer**
- Facility staff will ensure safe traffic flow during set times prior and after each session.
- Facility exit access will be restricted to 5-15 minutes after the scheduled start time.
- A maximum number of participants (including coaches & team support staff) will be enforced at all times.
- Field: A maximum of 50 persons/field is permitted on the playing surface at any one time. (this number will be expanded per public health guidance when possible)

MAIN Facility Entrance – Back door- end of the hall- see directional signage

Current main entrance will be used as an Exit only option- see directional signage

Check-in desk in main lobby area, prior to revolving door (1 facility staff required)

Facility staff member will verify the on-line form registration as well as take the participants temperature using a non-touch thermal thermometer.

Dome- Revolving door (1 facility staff required)

- Entrance to dome - revolving door- IN- the 45min. mark of each hr. this will be an in only entry point to the dome.
- Exit of dome - revolving door- OUT- the first 15min. of each hr. this will be an exit only point of the dome.
- The door will be sanitized, all touch points after each group has entered or exited the dome.

The facility staff member will alternate from lobby location and dome location. They will direct the participants accordingly.

Sanitizing station

Location: Lobby at revolving door, each participant is required to hand-sanitize prior to entering the dome using the door.

Location: in dome at exit revolving door, each participant is required to hand-sanitize prior to exiting the dome using the door.

General Signage

Outside- directional signs will be placed displaying drop-off and point of entry/exit.

Lobby

- check-in desk- floor signs will indicate standing points and will adhere to distancing regulations.
- Barriers will indicate entry and exit paths

Dome

- Barriers will indicate entry and exit paths as well as waiting areas
- Staging area will be defined as FIELD #1, 2 or 3 WAITING AREA
- Field entry directional signs FIELD #1, 2 or 3 SIDELINE →
- Field exit points- EXIT THIS WAY → (at end of each sideline on north side + at the corner of NE end of dome)

Sign listing:

DROP OFF ONLY (outside at start of roundabout)

EXIT ONLY (outside in front of current main doors)

ENTRANCE THIS WAY → (outside directing people to the back door)

ENTER HERE (on outside of the new entrance door at back)

CHECK-IN HERE (table top sign at check in desk)

PLEASE SANITIZE YOUR HANDS (table top signs on every sanitization station table)

Field logistics

In addition to the current mesh field separators/curtains, Tarps will be used to create rooms to help promote distancing regulations. Tarps will be sanitized daily.

Entry point will be contained to one side of the dome, exit point will be the other.

Waiting area (IN) 3 waiting areas

All participants will be directed to their appropriate field waiting areas no earlier than 15min. prior to their field start time.

Waiting area (OUT) 3 waiting areas

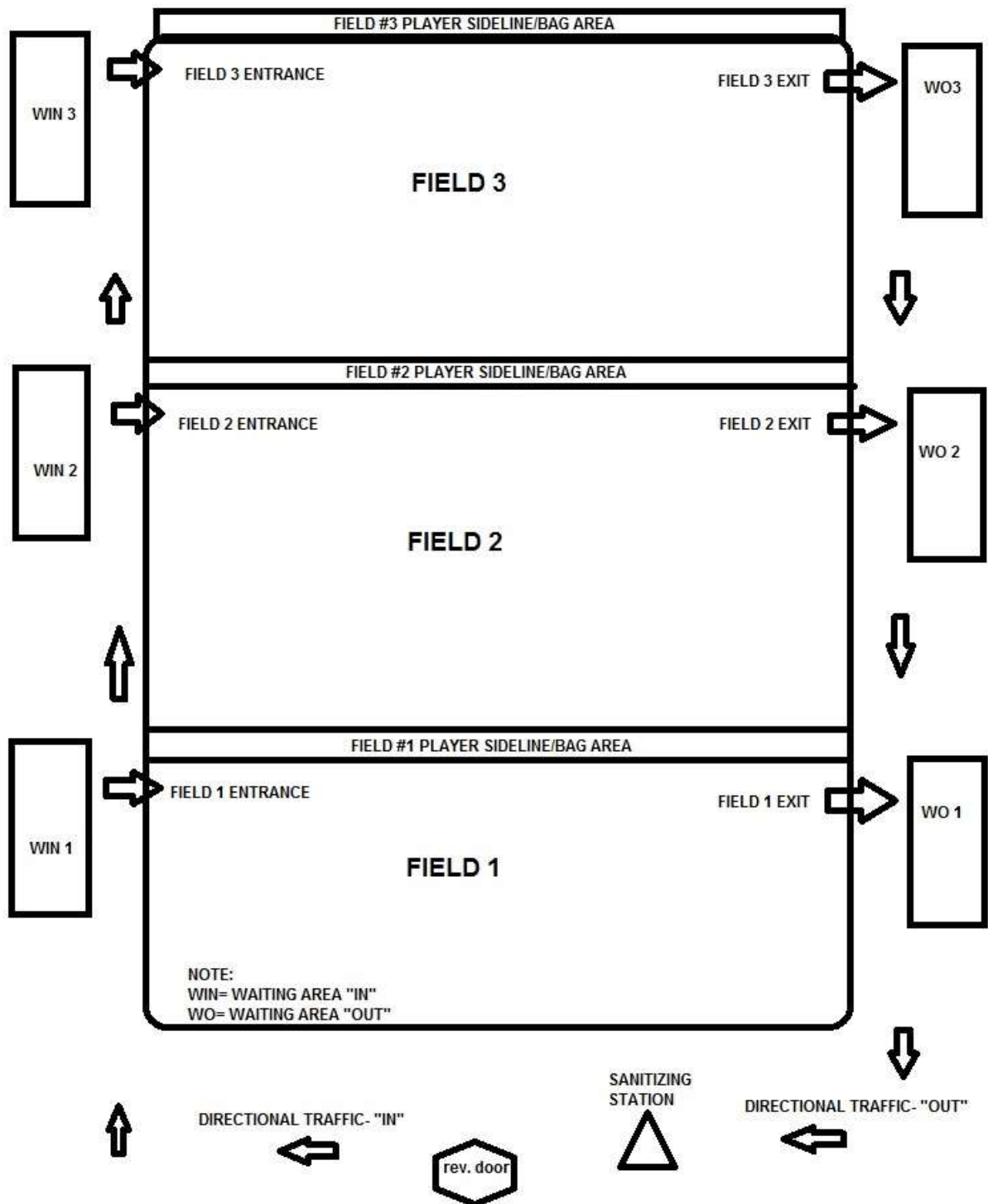
All participants will be directed to their appropriate field waiting areas immediately after their field session. Facility staff will ensure safe traffic flow during set times prior and after each session and direct as required.

GENERAL PROTOCOLS

The health and safety of our staff and customers is of the utmost importance to management and ownership of the Superdomes. Our goal is to reopen so community groups can enjoy their sporting activities indoors this fall, winter and the years to come. To minimize the risk of contracting COVID-19, the following list is the safety protocol that will be followed at the facility.

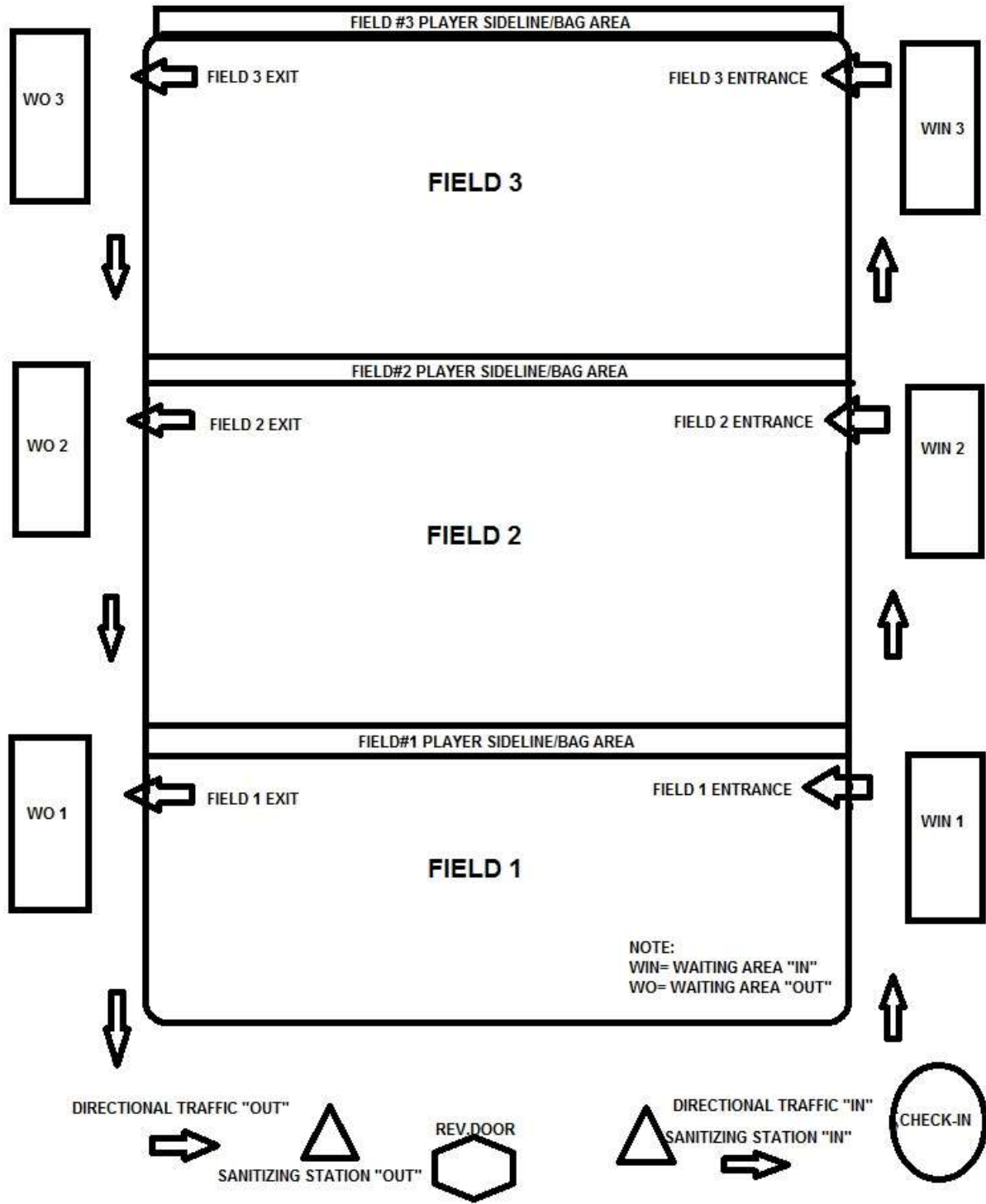
- Clubhouse will be closed, including change rooms Washrooms will have limited access.
- **NO** spectators or parents inside the facility, participants and coaching staff **ONLY**. A staff member will be at the entrance to enforce this safety measure.
- Entry & exiting of the building- staff will control access into and out of the facility.
- All persons entering the facility **MUST wear a mask AT ALL TIMES** except while practising or playing a game on one of the 3 sports fields.
- Staff will be required to wear proper PPE, including a mask, at all times. These will be provided to staff.
- 2 Auto-cleaning Needlepoint Bipolar Ionization systems installed in the rooftop air units of the clubhouse building.
- New professional germicidal UVC turf equipment to disinfect the field after closing will be used. All Hard to access areas i.e. walls, floors, doors of the complete facility will also be UVC disinfected.
- External Professional Cleaning Company conducting bi-weekly disinfecting of all building walls, floors, doors and revolving door with a Health Canada approved microbial shield-type product.
- Daily professional cleaning of the facility will be conducted.
- Staff continually disinfecting and sanitizing all touch points in the facility during open hours including but not limited to doors and handles, counter tops, etc.
- Several hand sanitizing stations throughout the entire facility including 1 on each side of the revolving door.
- DOME ENTER/EXIT-Revolving door is a push through style; users can use their bodies to push, eliminating the use of hands. It will serve as both the entrance and exit to/from the dome.
